POLICE REPORT – Chief Busler gave the monthly police report. Argo PD had 495 calls for the month of November 2024.

Councilperson Hopkins made a motion to accept the Wiregrass Construction Road Proposal, not

to exceed \$725,000.00, for road repairs to be paid from ARPA Funds, General Fund and Road Funds. Mayor Pro-Tem Brown seconded the motion. Mayor Bradley called for roll call of votes: Suggs- yes, Hopkins-yes, McCarley-yes, Brown- yes, Bradley-yes. Motion carried.
